At Ola, the Bengaluru-headquartered ride-hailing firm, the answer has been to stick to the knitting. Launched in London this week, it has retained the brand name and, in advertising campaigns, Ola is highlighting the safety features it developed for Indian roads. For instance, the twostep identification for Indian passengers whereby they share an OTP code with the driver to ensure that the cab they booked is the cab they are riding in, makes its way to the ride's London experience.
